**D-2:** Ten projects were chosen through an evaluation process during the 2011 Sustainable Communities Regional Planning process. These were identified as vital to moving forward many of the preliminary work group recommendations. Funding was awarded in the Fall of 2012 by USDA Rural Development. **D-3: Hazard Mitigation Plans.** Hazard mitigation planning is designed to protect the health, safety, and economic interests of citizens by reducing the impacts of natural, technological, and human-related hazards. The resulting plans provide steps to be taken to help reduce injuries, loss of life, and destruction of property due to hazardous conditions. R5DC, as part of the work to build resilient communities, continues to work with Cass County, Crow Wing County, Morrison County, Todd County and Wadena County and has been approached by the Leech Lake Tribe to prepare these vital documents. The Morrison County, Wadena County, Cass, Crow Wing County and Todd County plans are included on the resilient region site (http://www.resilientregion.org/economic-development/)

**D-4:** Solar Thermal in Central MN: Solar Feasibility Analysis for Local Units of Government was conducted by the Rural Renewable Energy Alliance (RREAL) to support the regional planning efforts. Local Units of Government throughout Region Five face the challenge of financing growing expenditures for essential services in the presence of continued budget cuts. The RREAL study assessed the potential for solar thermal technologies to stabilize and reduce municipal heating costs. This lead to a pilot project at the Brainerd Lakes Regional Airport funded by USDA. The efficiency and effectiveness is being evaluated and the results will be released at a later date. D-5: Central Minnesota Food Hub was a feasibility study conducted by Happy Dancing Turtle in partnership with Agricultural utilization Research Institute (AURI), Central Lakes College Small Business Development Center, the Farm on St. Mathias, the Initiative Foundation, JBJ World LLC, Region Five Development Commission, University of Minnesota Central Regional Sustainable Development Partnership, and University of Minnesota Center for Urban and Regional Affairs (CURA). The overall results provide "strong evidence supporting the development of a food hub in Central Minnesota." This work will help support the HUD/DOT/EPA Sustainable Communities Resilient Regional plan by providing crucial information needed for Recommendation EC2 "Local Foods: Promote and support the expansion of the local food economic sector."

Leveraged Resources! More than \$4.86 Million Dollars! A final accounting of the resources devoted to and leveraged for both planning and implementation will be provided as part of the HUD/DOT/EPA Final Report. As of November 16, 2012 more than \$4.86 Million had been leveraged for implementation of projects (during the planning process) and to help with projects identified as recommendations in the final plan (Accounting of Resilient Region Investment). This figure will change as grantwriting projects and pending proposals continue to be drafted at the time of this report. This represents only a portion of all resources leveraged. A conservative estimate is that at minimum the \$800,000 grant was matched; however, this does not include the total inkind contribution. The 610 community members contributed an additional \$149,654 (610 members, 6,868 hours, @ \$21.79 per hour).
